#### 1. Welcome

#### Richard Sankey - Chairman, KSDSFB.

#### 7. Directors Report

A copy of the report was circulated for review prior to the meeting.

#### 8. Budget & Finance

a. 2018-2019 Budget

Legal provision was £2K, spent £5K.

UHI genetics forecast £3K not used as outcome delayed.

Pension oversight of £4.5K due to an historical error.

Original Forecast for the year was for a £18.5K deficit, Now projecting around £7K deficit with a final healthy balance of around £90K inclusive of ring-fenced activities.

#### b. 2019-2020 Budget approval

3% salary increase.

79p assessment remains the same as 2018-19.

Reduced the Boards donation to the Trust from 10K to 5K.

Legal Fees contingency has been increased to £5K.

Reserves policy – RS noted that now that the assessment appeals had been dealt with, the budget and reserves were broadly in line with where they should be. Vehicle policy – no new vehicle 2019/20. We have 4 x L200 and 1 Hilux. Three new vehicles were purchased in the previous financial year. Replacement policy is 1 at year 3, 1 at year 4 and 1 at year 5.

Trap Rental line 95 should say Trust Trap Rental. **Action JH (11)**Provide AS with a breakdown of our forecasted SSE income for 2019/20 **Action KW/JH (12)** 

2019/2020 Budget approved by the Board.

#### c. Croick Church Repayment

It appears that the Croick Church never had ownership rights to fish the Blackwater and have therefore asked to be removed from the assessment roll and be refunded.

**Action KW (13)** – Refund to Croick church and discuss ownership with James Hall. Check required on any limitations to period of rebate.

#### 9. Carron

Glean Beag -

Salmon have been sighted above Glean Beag. It is possible this has occurred by swimming through scour sluice when winter plate is being inserted into compensation flow chamber on the 1<sup>st</sup> October. It is possible that fish can also pass the structure in high flows.

One solution is to change level of compensation flow via a 'compromise' plate that stays in all year round.

AS – The CAR licence is complicated and it is unknown if the present arrangements are compliant.

RF- The flow is a 'hands-off' flow rather than compensation flow. There is no logic to a winter flow plate. Keen to see changes made.

AS- It is happening.

RS- Science and evidence is required to make changes and will deliver long term benefits.

AS- It has become evident the freshet system is sophisticated and that the tunnel screens may have altered things, particularly when partially blocked. It is likely the screens will be removed.

RF- Intake removes 10 cubic metres of water per second when full, 200 million gallons a day. Changes may benefit SSE and the fish, it is a win win scenario. Reach consensus that this is way forward.

RS- Emphasised the importance of ongoing monitoring that leads into decision making. Use evidence and monitoring as any changes may require some degree of tweaking and rebalancing. Apply adaptive management.

PR- How many extraction points is the summer level more than the winter level? RF responded that all the compensation or 'hands-off' flow comes from the structure at Gleann Beag.

AS- Historically the flows were not designed for young fish.

RS- We now think of the fish first.

Radio Tracking -

KW- Spoken to Johnny Shaw and Nicholas Forman hardy and they are supportive of the radio tracking project on the Carron.

NG- Who is doing that work on the ground? Glencalvie have a new ghillie. KW will continue to liaise with the estates.

RS- Is there a wisdom in catching lower down Glencalvie? SM- If they don't make it past Glencalvie Falls early enough, they are not fit and won't make it anyway. Fish can go early at right temperature and flow.

RS- They are hard wired to the environment, rest in pools or keep running.

RF- SEPA concerned this year will be another low flow summer.

RS- To sum up are we happy with strategy? It was agreed that things were moving in right direction.

RF- offered to attend Carron proprietors meeting.

RS- informed NG that if CPG wanted anyone from the Board to attend their meeting he was happy to do so.

**Action KW/RS (1)** Ensure the main players see sight of the tracking proposal. RS/KW set terms of reference.

Rainbow Trout have been seen up and down the Carron. 1 has been caught this season and more seen jumping.

RS- Brown and rainbow trout stocking is licensed by Marine Scotland and the Board has no authority. There is a disconnection from appropriate stocking of trout, and this is happening all over Scotland. Trout stocking can potentially result in the introduction of signal crayfish.

AS- Trout stocking is a significant bio-hazard.

PR- Appalling lack of control compared to the historical situation.
